Fee Changes

Fees in effect 7/1/09.

Excessive withdrawal fee if your regular share (savings) balance is under \$200

- **OLD:** 3 free withdrawals per quarter, \$2 for the 4th and each additional withdrawal in the same quarter
- **NEW:** 3 free withdrawals per quarter, \$3 for the 4th and each additional withdrawal in the same quarter

Withdrawal by mail fee

- OLD: None
- **NEW:** \$2 for withdrawals less than \$200 if your regular share account balance is also under \$200

Dormant share (savings) account service charge

- OLD: \$2 per month for accounts under \$50 with no activity for 12 months
- **NEW**: \$5 per month for accounts under \$200 with no activity for 12 months
